

# **Expression of Interest**

Triathlon Queensland is currently seeking expressions of interest from people who wish to be considered for the position of an Interested Director on the Board of Triathlon Queensland. Expressions of interest should be received by Triathlon Queensland before close of business on Monday, 3<sup>rd</sup> October 2016.

Triathlon Queensland's Annual General Meeting will take place on Monday the 17<sup>th</sup> of October 2016.

#### **About Triathlon Queensland**

Triathlon Queensland is the state governing body responsible for the strategic development of the sport of triathlon in Queensland. There are 69 Triathlon Queensland Affiliated Triathlon Clubs who are regarded as voting members. Triathlon Queensland are responsible for administering approximately 6,200 individual Triathlon Australia members and 46,000 event participants in Queensland.

As an affiliated State and Territory Triathlon Association with Triathlon Australia (a recognized International Triathlon Union and Australian Sports Comission National Federation), Triathlon Queensland seeks to foster the growth and development of triathlon in Queensland, as well as continuously grow, strengthen and connect the triathlon community and every starting line in Queensland.

## The Board

The Triathlon Queensland Board under Clause 25 of the Triathlon Queensland Constitution is comprised of up to six elected Interested Directors, including a President, and two Independent Directors who collectively have the skills, knowledge, experience and attributes to effectively govern the organisation.

It is desirable, but not required, for Directors to have an understanding of Queensland's sport environment and the role and contribution of a State Sporting Organisation and/or an understanding of member-based organisations and the expectations of members, participants, volunteers and clubs.

Consistent with our commitment to diversity, candidates are encouraged to apply with respect to; gender, age, culture, and background.





## **Organisational Environment**

Triathlon Queensland operates in a dynamic sporting environment, and these director appointment opportunities are crucial to the continued success of the organisation.

Specifically encouraged to apply are those with commercial experience, a background or qualifications in law, finance, governance, human resources or similar.

Whilst it is desirable that nominations should cover these areas of expertise, applications from outside these areas will be considered.

## **Positions on the Board**

At the 2016 Annual General Meeting, two (2) Interested Directors (Mark Browne and Martin Leech) will vacate the positions they hold.

Two (2) Interested Directors (Margie Luxford and Robert Eley) and one (1) President (Brad Gunn) will remain on the board until the 2017 Annual General Meeting.

At the 2016 Annual General Meeting, the members must elect at least two (2), no more than three (3), interested directors to serve for a period of 2 years ending at the 2018 Annual General Meeting.
